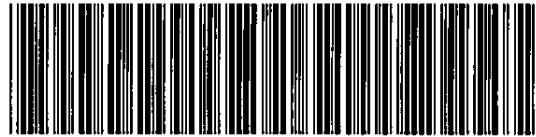

The mailing and street address of the principal office of the limited liability company is: 11415 SW 113th Terrace, MIAMI, FL 33176.

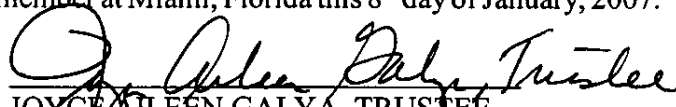
ARTICLE V INITIAL REGISTERED AGENT
