## ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I

##### NAME

##### PURPOSES AND POWERS


**ARTICLE VI****MANAGER**

The managers shall be elected in the manner set forth in the Operating Agreement of the Company. **ARTICLE VII****DURATION**
