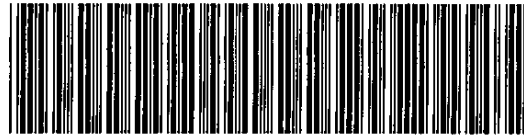

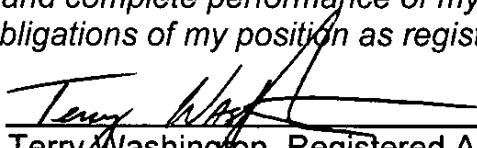

The regulation of the internal affairs of the Company shall be set out in the Operating Agreement of the Company.
