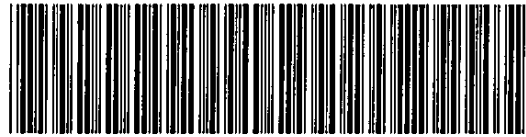



**ARTICLES OF ORGANIZATION  
OF  
A&E ENTERPRISES OF TAMPA BAY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be A&E ENTERPRISES OF TAMPA BAY, LLC ("Company").

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company in Florida is 3450 18<sup>th</sup> Avenue South, St. Petersburg, FL 33711.

**ARTICLE III - DURATION**

The Company's existence shall commence upon the acceptance of the Articles of Organization by the Florida Department of State and shall continue in existence until the expiration of fifty (50) years from such commencement date, unless sooner terminated, liquidated or dissolved by law or by the unanimous consent of the Member(s).

**ARTICLE IV - MANAGEMENT**

The Company shall be managed by one or more managing members in accordance with the Operation Agreement adopted by the members for the management of the business and affairs of the Company. This Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. The name and address of the initial managing member of the Company is: Luxley Farrell, 3450 18<sup>th</sup> Avenue South, St. Petersburg, FL 33711.

**ARTICLE V - ADMISSION OF NEW MEMBERS**

The right, if given, of the members to admit additional members and the terms and conditions of the admission shall be:

The manager may admit new members in its sole and unfettered discretion subject only to the condition that such additional member must agree in writing to be bound as a member by the Operating Agreement of the Company.

#### ARTICLE VI – MEMBERS RIGHTS TO CONTINUE BUSINESS

The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall not terminate the company, and the business of the company shall be automatically continued, so long as there is at least one remaining member.

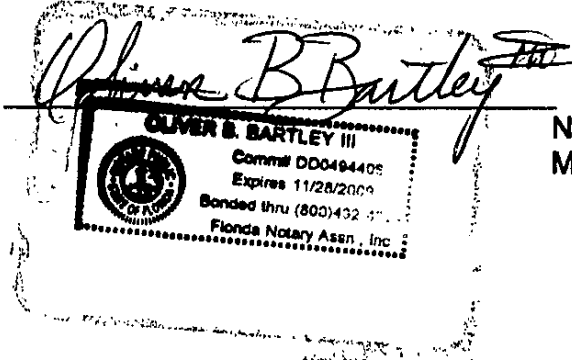
