



AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
JOHNSON HOMESTEAD, LLC

The undersigned, JUNE ROBERTSON ("Member"), being the sole member of Johnson Homestead, LLC (the "Company") and having the requisite consent, hereby files these Amended and Restated Articles of Organization for the purpose of amending the original Articles of Organization and restating the remaining provisions of the Articles of Organization as set forth herein. The original Articles of Organization for the Company were filed on January 11, 2007.

1. NAME AND PRINCIPAL PLACE OF BUSINESS

1.1 The name of the limited liability company shall be **Johnson Homestead, LLC** and its principal office shall be located at 4996 S. W. Addison Avenue, Arcadia, FL 34266, County of Desoto, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

SECTION 3 IS AMENDED AS FOLLOWS:

2. EXERCISE OF POWERS

2.1 All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the director of one or more managers. 

5.1 The effective date for these Amended and Restated Articles shall be the date of filing.


