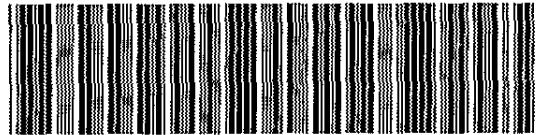

ARTICLE II: PRINCIPAL OFFICE


