ARTICLE I

The name of the Company is LJE Holdings, LLC.

ARTICLE II

or upon the occurrence of any other event which pursuant to the Operating Agreement or state law
terminates the continued membership of a member in the Company, the remaining members may,
by unanimous vote, within ninety (90) days, elect to continue the business of the Company. The
member or members shall forthwith execute and record an amendment to the Articles of
Organization to evidence such continuation, if required by appropriate governing law.

ARTICLE VIII

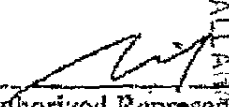
The net profits and losses of the Company for any year shall be allocated among the members in accordance with the Operating Agreement.
