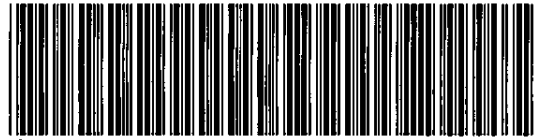

All the remaining property, cash and assets (if any) of the Company have been distributed among its members according to their respective rights and interests.



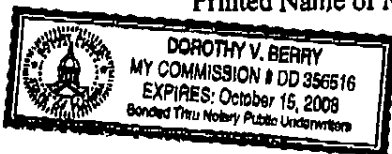
