

ARTICLES OF ORGANIZATION OF FALCON AIRLINE ACADEMY, LLC

Article I

The name of the limited liability company ("Company") is FALCON AIRLINE ACADEMY, LLC.

Article II

The mailing and street address of the Company's principal office is 2576 Shady Lane, Orange City, Florida 32763. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.
