ARTICLES OF ORGANIZATION

OF

HOMESEARCH PROPERTY MANAGEMENT, LLC

ALTHOUGH BRIDE The undersigned, for the purpose of forming a limited liability company under the Flor Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Homesearch Property Management, LLC ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company shall be 1810 El Jobean Road, Unit 5, Port Charlotte, Florida 33948.

ARTICLE III - DURATION
