

ARTICLES OF ORGANIZATION



SYNDICATE MANAGEMENT GROUP LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **SYNDICATE MANAGEMENT GROUP LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 220 Petunia Terrace, #306, Sanford, Florida 32793 and the mailing address shall be PO Box 5482, Winter Park, Florida 32771.

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.
