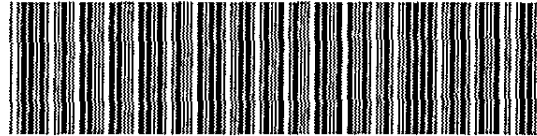

Pursuant to Section 608.407 of the Florida Statutes, we herewith submit these Articles of Organization to form a Limited Liability Company For-Profit , in the State of Florida, and for the purposes, goals, and requirements hereinafter set forth,
TO WIT:

ARTICLES I: Name of the Company

The name of this Limited Liability Company shall be 'The Ritson Agency LLC 'and it shall engage in the business of an insurance agency, offering a variety of insurance policies; products; and coverages to the residents of the Florida Keys and other residents throughout the State of Florida, and providing insurance education and information, financial planning advice and strategies; and related other services. 
Additional members, managers, and managing members may be added, from time to time, by approval and agreement of the members of this limited liability company, in accordance with the by-laws of this organization ..




