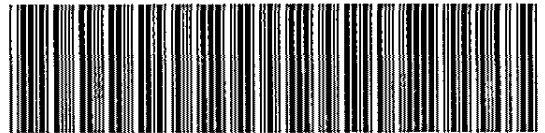

SECOND: This amendment is submitted to amend the following:


The name of the corporation from Moody & Associates, LLC to McCall Moody Law Firm, PL
