## ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF GARDENS MEDICAL PAVILION, LLC

SECOND: The Original Articles were amended and restated by Amended and Restated Articles of Organization for Gardens Medical Pavilion, LLC filed December 16, 2010 (the "Amended and Restated Articles"), which Amended and Restated Articles amend and restate the Original Articles in their entirety.

THIRD: Article IV - Management of the Amended and Restated Articles is hereby deleted in its entirety and replaced with the following:
