# ARTICLES OF ORGANIZATION OF 2609 HILL STREET, LLC

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I NAME AND ADDRESS

The name of the limited liability company shall be 2609 HILL STREET, LLC ("Company").
