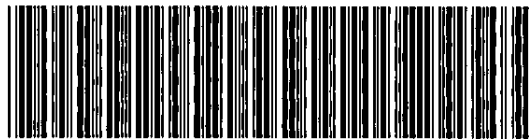

**ARTICLE I**

**TERMS OF EXISTENCE**


