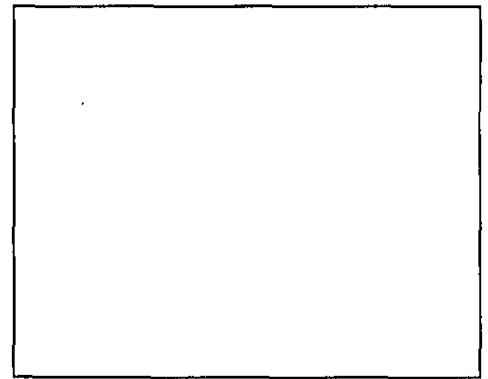

The name of this limited liability company is Project Trio LLC, a Florida limited liability company.




