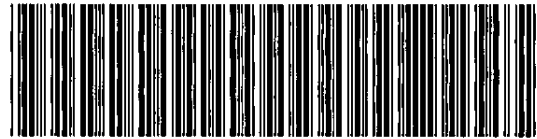



The Articles of Organization of said Limited Liability Company are amended as follows:




Robert D. George	50%



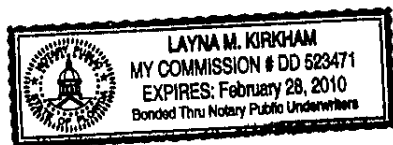
