1. The name of the limited liability company is Bakchos Management, L.L.C.
2. The effective date of this dissolution is November 13, 2009.
3. The occurrence that resulted in this dissolution was the death on September 25, 2009 of the sole managing member, namely Mark A. James, and the determination by the duly appointed personal representative, Jason D. James, that the outstanding liabilities of the company exceeded its assets, it is insolvent, and continuation of its business is not reasonably practicable.
4. Jason D. James as Personal Representative of the sole and last managing member has marshaled all assets, which amount to \$6,000.00.
