

ARTICLES OF ORGANIZATION HAILEY JORDAN CONSTRUCTION, LLC

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I NAME OF COMPANY

The name of the limited liability company is Hailey Jordan Construction, LLC (the "Company").

ARTICLE II PERIOD OF DURATION

The Company shall terminate on January 16, 2106.

ARTICLE III **REGISTERED OFFICE AND AGENT**
