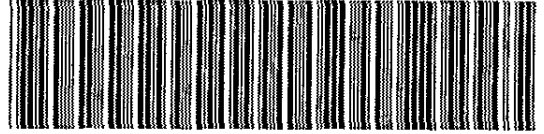

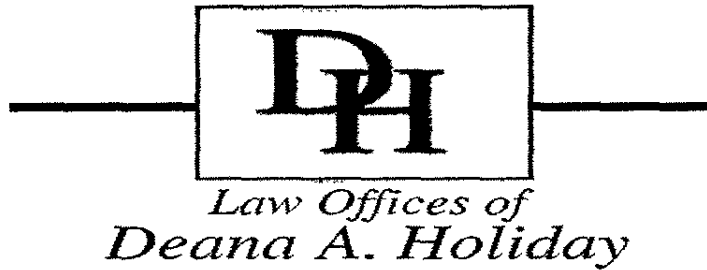


**ARTICLE III - PURPOSE**
