

ARTICLES OF ORGANIZATION OF ATI HOMES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be ATI HOMES, LLC, ("company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 29652 SR 19, Tavares, FL 32778.

ARTICLE III - DURATION
