

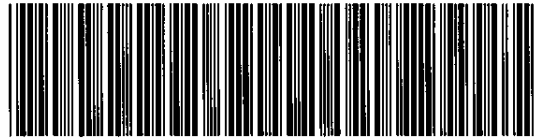


ARTICLE VI - GOVERNED BY OPERATING AGREEMENT
