

ARTICLES OF ORGANIZATION OF

THE TACK SHACK, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is THE TACK SHACK, LLC.

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in THE TACK SHACK, LLC, the remaining members may, by unanimous agreement, continue the business of THE TACK SHACK, LLC.
