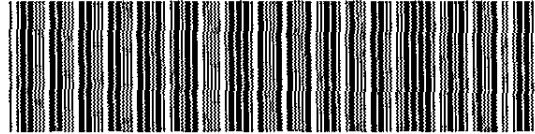

ARTICLES OF ORGANIZATION

NAME

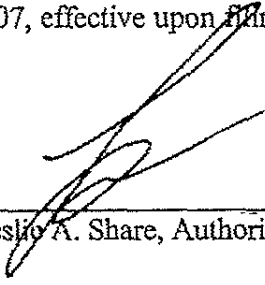

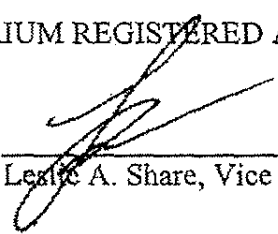
