## Articles of Organization

## HERITAGE PROPERTIES OF NORTH FLORIDA Limited Liability Company

THESE ARTICLES OF ORGANIZATION forming a limited liability company under the laws of the State of Utah are made and executed this 22nd day of January, 2007, by the undersigned.

- 1. Name. The name of the limited liability company is **Heritage Properties of North Florida** Limited Liability Co. (hereinafter referred to as the "Company").
- 2. Term. The term or period of duration of the Company shall commence as of the date of the filing of these Articles of Organization with the Utah Division of Corporations and Commercial Code and shall continue for a term of twenty (20) years from that date, unless sooner terminated pursuant to law or the provisions of the Company's Operating Agreement.
- 3. **Business Purpose**. 5. **Substitute Service of Process**. The Division of Corporations and Commercial Code of the Florida Department of Commerce is hereby appointed as the

6. **Management**. The management of the company shall be vested in the Managers and a majority of the Managers voting shall be necessary for all decisions affecting the Company.
