The undersigned subscribers to these articles of organization, being duly licensed to practice law under the laws of the State of Florida, adopt these articles to form a professional limited liability company under the provisions of Chapters 608 and 621, Florida Statutes and other laws of the state of Florida, for the purposes of providing such professional services as specified herein.

ARTICLE I. NAME

The name of the professional limited liability company is Stokley & Stevens, P.L. (hereinafter "Company")

§ ARTICLE II. PRINCIPAL OFFICE

The principal office of the Company is 1332 Avondale Avenue, Jacksonville, Florida 32205 and the mailing address is 1650 Margaret St., Ste. 302, PMB #312; Jacksonville, FL 32204.

§ ARTICLE III. PURPOSE

The Company is formed to engage in every phase and aspect of the practice of law. § ARTICLE IV. TERM OF EXISTENCE


