ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Section 608.411, Florida Statutes, 2010 CONVENTION, LLC, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:
