

These Amended and Restated Articles of Organization were adopted by the members pursuant to section 608.411, Florida Statutes. The Company's original Articles of Organization were filed on January 25, 2007.



Article V. Transferability of Membership Interests

Unless otherwise provided in the Company's Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of members who own more than 50% of the voting interest in the Company. The voting members shall have complete discretion on when and if to approve any distribution of profits.
