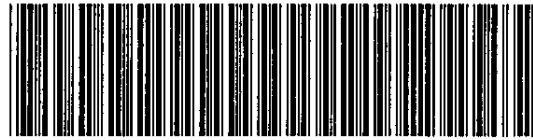

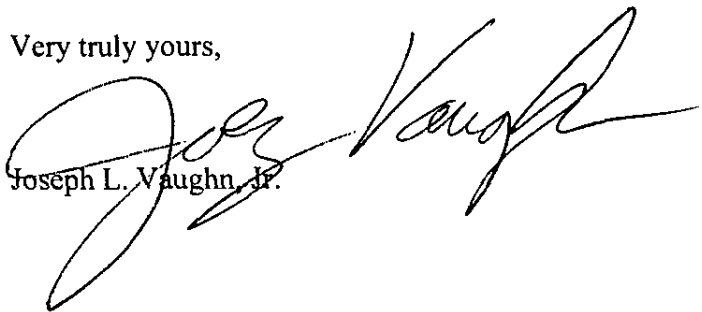

**ARTICLES OF ORGANIZATION

In compliance with Chapter 608, Florida Statutes, the undersigned person, acting as the organizer of PAXTON & ASSOCIATES, LLC, does hereby adopt and file the following Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act.

**ARTICLE I

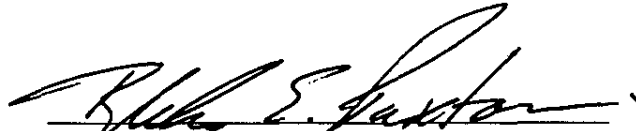
