### ARTICLES OF ORGANIZATION OF SOUTH WALTON REAL ESTATE COMPANY, L.L.C.

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does hereby set forth the following:

#### ARTICLE I

#### **NAME**

The name of the limited liability company shall be **South Walton Real Estate Company, L.L.C.**, (hereinafter referred to as the "Company").

#### ARTICLE II

#### ADDRESS OF PLACE OF BUSINESS

The Company's principal place and of business and mailing address shall be 3524 Burnt Pine Lane, Destin, FL 32550, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

#### ARTICLE III

#### **DURATION**

The period of duration of the Company shall be perpetual, and shall be from the date of filing of its Articles of Organization until the first to occur of the following:

(1) Dissolution of the Company pursuant to the provisions of the Florida Limited Liability Company Act; or

(2) By the written agreement of a majority in capital interest of the Members.

#### **ARTICLE IV**

#### **MEMBERS**

The Company shall have at least one (1) Member, and may admit additional members upon the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating Agreement. The initial sole Member shall be Bradley Vroon, whose address is 3524 Burnt Pine Lane, Destin, FL 32550.

#### **ARTICLE V**

#### PROFITS AND LOSSES

- (a) Sharing of Profits. The members shall be entitled to the net profits arising from the operation of the Company business that remain after the payment of the expenses of conducting the business of the Company. Each member shall be entitled to the distributed share of the profits specified in accordance with the percentage of membership interests that each member owns related to the total membership interests outstanding.
- (b) **Losses**. All losses that occur in the operation of the Company business and the profits of the business, or, if such sources are insufficient to cover such losses, by the members in accordance with the percentage of membership interests that each member owns related to the total membership interests outstanding.

#### **ARTICLE VI**

#### <u>MANAGEMENT</u>

The Company shall be managed by the managing members; however, all of the following shall require a fifty-one percent (51%) vote from the members:

- a. assigning property to creditors or other assignees;
- b. confessing a judgment;
- c. submitting a claim to arbitration;
- d. executing and delivering any debt instruments;
- e. conveying real or personal property of South Walton Real Estate

  Company, L.L.C.;
- f. pledging a member's membership interests to individuals or entities outside of South Walton Real Estate Company, L.L.C.;
- g. disposing of the goodwill of the company.
