### TALLAHASSEE COMMERCIAL PROPERTIES, THE STATE OF STATE

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

#### 1. <u>NAME</u>.

The name of the Limited Liability Company is **TALLAHASSEE COMMERCIAL PROPERTIES, LLC** (hereinafter referred to as the "Company").

#### 2. **PERIOD OF DURATION**.
