Articles of Dissolution of Lake Simmons Grove, LLC

The undersigned hereby executes and adopts the following Articles of Dissolution for Lake Simmons Grove, LLC, a Florida limited liability company, pursuant to Section 608.445, Florida Statutes (2009), and states:

1. The name of the limited liability company is Lake Simmons Grove, LLC (the "Company").

2. The effective date of the Company's dissolution is April 9, 2010.

3. The Company was dissolved by the written consent of all of its members pursuant to Section 608.441(c), Florida Statutes (2009), and as authorized by the Company's Operating Agreement. The Operating Agreement provides that the Company shall be dissolved upon the unanimous written consent of the members and the Company's Articles of Organization do not contain any provisions to the contrary.

4. All debts, obligations, and liabilities of the Company have been paid.

5. All the remaining property and assets of the Company have been distributed among the Company's members in accordance with their respective rights and interests. As of the time of its dissolution, the Company had one member. As such, all of the remaining property and assets have been distributed to that member.

6. There are no suits pending against the Company in any court.

7. The undersigned is the sole member of the Company.
