

## **ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **LEAN SIGMA SOLUTIONS LLC**, ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 13717 Harbor Creek Place, Jacksonville, Florida 32224 and the mailing address shall be the same.
