ARTICLES OF ORGANIZATION

OF

VANYOUNG, LLC

The undersigned, for the purpose of forming a limited liability company and the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

<u>ARTICLE 1 - NAME</u>

The name of the limited liability company shall be VANYOUNG, LLC, ("Company").
