ARTICLES OF ORGANIZATION NINE TWELVE ENTERPRISES, LLC

OJ MAJO RA STAN The undersigned, for the purpose of forming a limited liability compa under the Florida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME
