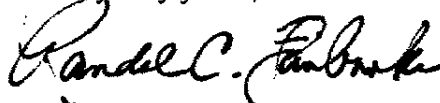

ARTICLES OF ORGANIZATION OF  
HAAS-PARKER LEASING, LLC**
