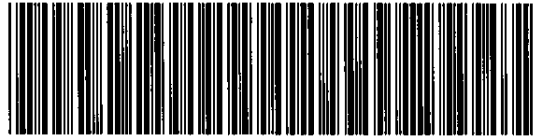

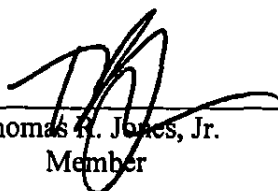
**ARTICLE IV

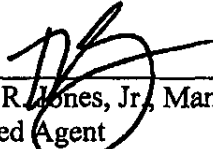
**CERTIFICATE OF ACCEPTANCE BY
