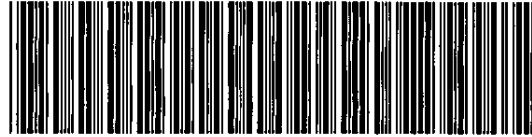

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company is C.D.S. ENTERPRISE, L.L.C.

ARTICLE II – ADDRESS

The principal place of business and mailing address of the Company in Florida shall be P.O. Box 20631, Tallahassee, Florida, 32316-0631.

ARTICLE III – PURPOSE

The purpose for which this Limited Liability Company is formed is to engage in any lawful act or activities for which limited liability companies may be formed under Chapter 608 of the Statutes of the State of Florida.

ARTICLE IV – DURATION

The period of duration of the L.L.C. is perpetual.

ARTICLE V –REGISTERED AGENT

The initial address of the registered agent is 4179 Miraflores Lane Tallahassee, Florida 32303. The name of the registered agent is Chuvala D. Snell-Brown.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.

ARTICLE VI- MANAGEMENT OF L.L.C.

The L.L.C. is to be managed by one or more managers, as provided for in the L.L.O. Operating Agreement and is, therefore, a manager-managed company. The management of the L.L.C. is reserved to its members. Chuvala Snell-Brown is designated as the initial managing member of the L.L.C. as of the date of filing of these Articles.

ARTICLE VII – MEMBERS

The Managers of the Company shall be elected by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization. ARTICLE VIII – ADDITION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the members proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE IX INDEMNIFICATION

The Company shall have the power to indemnify and hold harmless any member or manager or other person from and against any and all claims and demands whatsoever.

ARTICLE X MISCELLANEOUS PROVISIONS

All references in these Articles of Organization are deemed to include any amendment or successor thereto. All references in the Articles of Organization to "manager," "officer," "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
