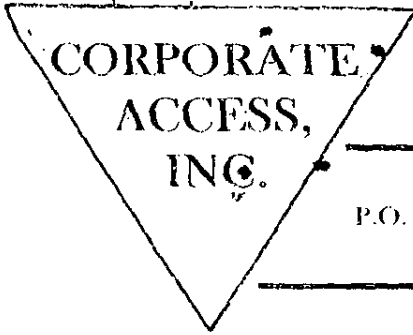

ARTICLE II - ADDRESS


