1. The Articles of Organization of ABBEY MANAGEMENT, LLC, a Florida limited liability company, were filed with the Florida Department of State on January 31, 2007.
2. Article VII of the Articles shall be deleted in its entirety and the following Article VII shall be inserted in full substitution therefor:

“ARTICLE VII - MANAGEMENT MY MANAGER
