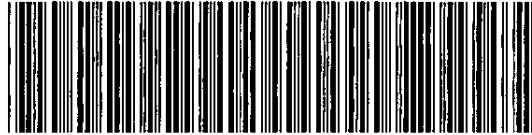

(A Florida Limited Liability Company)


1. The Articles of Organization of ABBEY REALTY, LLC, a Florida Limited Liability Company, were filed with the Florida Department of State on January 31, 2007.
