ARTICLES OF ORGANIZATION OF SOUTHWEST FLORIDA PUBLISHING, LLC

The undersigned certifies that for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit file these Articles of Organization. The undersigned further declares that the following Articles shall serve as the Charter and authority of the conduct of business of the limited liability company.

ARTICLE I NAME, PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The name of the limited liability company shall be **SOUTHWEST FLORIDA PUBLISHING, LLC**, and its mailing address and principal office shall be located at 308 S.E. 24th Terrace, in the City of Cape Coral, County of Lee, State of Florida but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.

- 5.
