OTER PARSE The undersigned does hereby execute these Articles of Organization for th purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I NAME

The name of the limited liability company shall be:

ARTICLE II PERIOD OF DURATION

The period of duration of the Limited Liability Company shall be perpetual.
