ARTICLES OF ORGANIZATION
OF

HOME TREASURES CONSULTING GROUP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be HOME TREASURES CONSULTING GROUP, LLC ("Company").

ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS

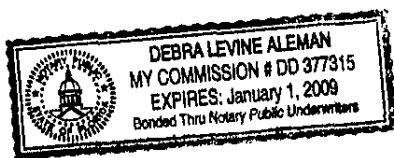
