## AGREEMENT, PLAN AND CERTIFICATE OF MERGER SECRETART OF STATE TALLAHASSEE, FLORIDA

THIS AGREEMENT, PLAN AND CERTIFICATE OF MERGER (the "Agreement") is made and entered into as of February 7, 2007, among THE BERMAN FAMILY III, LLC, a Florida limited liability company ("TBF III-FL"), and THE BERMAN FAMILY III, LLC, a Michigan limited liability company ("TBF III-MI"), under the Michigan Limited Liability Company Act (the "Michigan Act") and the Florida Limited Liability Company Act (the "Florida Act").

- iii All references to the State of Michigan shall be replaced with a reference to the State of Florida
- iv. Section 10 5 of Article X shall be amended in its entirety to read as follows: "Ihis Agreement shall be governed by the laws of the State of Florida"

#### 4. FILING OF AGREEMENT; EFFECTIVE DATE

- a Io cause the Merger to become effective, a copy of this Agreement will be filed with (i) the Michigan Department of Labor & Economic Growth Bureau of Commercial Services, pursuant to and in accordance with the Michigan Act and (ii) the Florida Secretary of State Division of Corporations, pursuant to and in accordance with the Florida Act
- b The effective date and time of the Merger (the "Effective Date") is the date of filing of this Agreement.
