ARTICLES OF ORGANIZATION

OF

ARTICLE I - Name:

In addition to the indemnification conferred in this Article, the indemnities shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such indemnities in advance of its final disposition, to the fallest extent authorized by applicable law, as the same exists or may becenfor be amended. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter soquire under any statute, provision of the Article of Organization or the Operating Agreement of the Company, agreement, vote of Members or otherwise. Any repeal or amendment of this Article by the Mambers of the Company stall not advancely affect any right or protection of a member, manager or officer existing at the time of moch repeal or amendment.

ARTICLE IX - Continuation of Business:

Unless dissolved in accombance with the Company's Operating Agreement, the remaining members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued exembership of a member.
