Pursuant to Section 608.4115, F.S., this document is being submitted within the required thirty (30) business days to correct the attached Articles of Organization.


1. The name of the limited liability company is HURRICANE WINGS OF JENSEN BEACH, LLC (the "Company").
2. The Articles of Organization were filed on February 6, 2007 and assigned document number L07000013276.
3. The Articles of Organization contain the following incorrect statements:
 - (a) In Article I, the name of the Company is incorrect because the members of the Company have agreed that it would be in the best interests of the Company to include a reference to location in the name of the Company. The correct name is: JENSEN BEACH GRILL AND WINGS, LLC.
 - (b) In Article V, the preparer of the Articles of Organization believed that all members of the Company were to be listed in the Articles of Organization and did not understand what the abbreviations of the titles meant. Jeffrey Arrigoni, a member of the Company, was listed as a manager of the Company. As only managers and managing members are to be listed in the Articles of Organization and Mr. Arrigoni holds neither position, his name and address should be deleted entirely from Article V of the Articles of Organization.

The corporate indicator "Inc." at the end of the managing member's name was mistyped. The correct corporate indicator is "Corporation." The full correct name of the managing member is: One Casa Corporation.

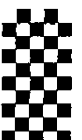
