ARTICLES OF ORGANIZATION

OF

SALOON III ENTERTAINMENT, LLC.,

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statue 608, hereby make, acknowledge, and file the Articles of Organization.

ARTICLE I -- NAME

The name of the Limited Liability Company shall be SALOON III ENTERTAINMENT, LLC., (herein referred to as "the company").

- 1. To engage in any activity or business authorized under the Florida Statutes.

- 3. - 4. To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescingany of such contracts.
- 5. To exercise all or any of the limited liability company powers, and to carry out affor any of the purposes, enumerated in these Articles and otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact for any persons or corporations and perform any service under contract or otherwise for any corporation, joint stocked company, association, partnership, firm, syndicate, individual, or other entity, and in this capacity or under this arrangement develop, improve, stabilize, strengthen, or extend the property and commercial interest of the property and to aid, assist, or participate in any lawful enterprise in connection with or incidental to the agency, representation, or service, and to render any other service or assistance it may lawfully do under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
- 6. 
