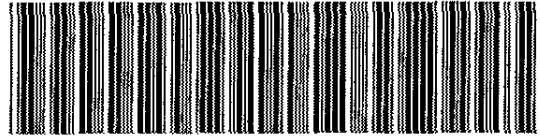




ARTICLE VII
